# 2024 Breckenridge Resident & Summit/Park County Local Rate

In 2024 we will not be issuing punch cards to local players. Instead, we will be offering a local rate. Those who previously qualified for a punch card will now qualify for a day rate. You will no longer be paying for all your rounds up front, each round will be charged day of booking or at check-in. We will build you a customer profile based on the information given below and you will be locked in at that given rate. We will be verifying all the information given before building the profile.

Valid Breckenridge Rate: \$25 for 9-holes and \$50 for 18-holes. Cart not included. -This is for property owners, business license owners or voters in town limits only! (NO EXCEPTIONS) \*Timeshare deed holders do not qualify for local rate.

Valid Summit/Park County Rate: \$32 for 9-holes and \$64 for 18-holes. Cart not included.

Junior Breck/Summit/Park County Rate (18 or younger as of 6/1/24): \$19 for 9-holes and \$38 for 18-holes. Cart not included.

Must be 16 or older to drive a cart.

#### Usage

- Cart rental is **required before 1:00pm** for all golfers on **Saturday** and **Sunday**.
- No spectators before 1:00pm.
- Spectator cart fee is \$12 for 9-holes and \$20 for 18-holes.

## **Reservation Policy**

- 8 advance (\$20) tee times will be issued to each qualifying Breckenridge Resident & Summit/Park Resident.
- Tee times may be made **four-days** in advance on a space available basis.
- Tee times are accepted online, by telephone, or in person at the golf shop.
- A maximum of two foursomes may be booked per phone call or in person.
- Tee times for organized club programs, may be booked per program guidelines.
- Tee times must be cancelled 24 hours in advance of the tee time.
- Tee times booked outside of the four-day window will be charged full price. NO REFUNDS, NO EXEPTIONS.

### **Bring A Friend**

Your account will have a limited number of **Bring a Friend**, punches that offer discounted rates. Usage is as follows.

- Low season rate is \$45 for 9-holes and \$70 for 18-holes. Cart not included.
- Shoulder season rate is \$60 for 9-holes and \$90 for 18-holes. Cart not included.
- High season rate is \$70 for 9-holes and \$100 for 18-holes. Cart not included.
- Saturday restrictions apply.
